

PROGRAM DESCRIPTION

Valia Capital Management is a 4.7 Exempt (QEP), 100% discretionary CTA. The head traders of Valia Capital Management are Anthony Lazzara, previous member of the CBOT and futures trader since 1990, and Jason Rotman, a graduate of Princeton University and futures trader since 2002. The objective of the Global Tactical Program is to achieve appreciation of clients' assets through **technical, short-term trading** (mainly 1-10 day holds). **Valia focuses primarily on 4 liquid markets:** e-mini SP500, WTI crude oil, gold, and bonds, with an approximate 5% window to trade other asset classes. Numerous technical inputs are continuously monitored for ideal risk/reward set-ups.

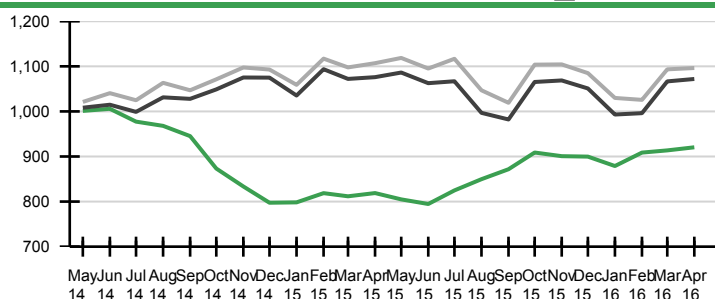
In 2015, Valia began to focus on: more liquid markets, more conservative risk management, and less aggressive position sizing.

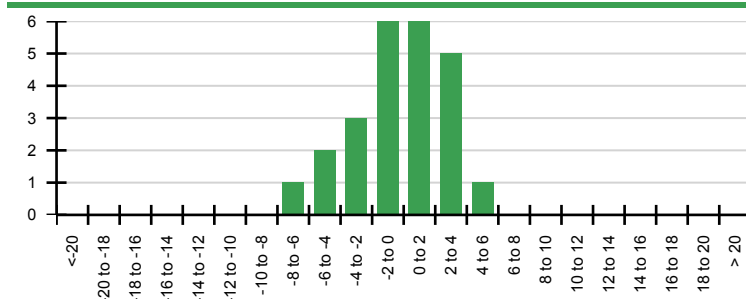
